**For submission to the import of the products in Turkey – Wireless
Bridge with BT and WLAN “ Wireless Bolt ”**

Dear Sir/Madam,

Turkish Telecommunications Authority is no longer responsible for the type approval of telecommunications products. The responsibility of the Telecommunications Authority will be in future the market surveillance of telecommunication products.

The “Under secretariat of Prime Ministry for Foreign Trade” is now responsible for telecommunications products. New is, that any telecommunications products which fulfills the R&TTE requirements (Directive 1999/5/EC) can be imported into Turkey. Turkey has accepted the EU requirements. These regulations will be adopted to the new RED in the near future.

The R&TTE Declaration of Conformity (DoC) from the manufacturer will be sufficient.

The local importer/distributor has to show the DoC for imported devices (class 2) if requested. The “Undersecretaries of Prime Ministry for Foreign Trade” is in charge of this issue.
